


### What is the Al Ethics Code?



This is a uniform system of guiding principles and rules designed to create an environment of trusted development of AI technologies

#### Important!

The Code does not define the ethics of AI. It helps to organize the relations between people and companies concerning development of AI

- State regulation is balanced by soft law instruments
- The document has a nonbinding nature
- Adherence to the Code is voluntary
- The Code applies only to civil developments

### What does the Code consist of?

The content of the Code is based on 6 main principles underlying the detailed recommendations:



- The key priority of AI technologies development to protect of the interests and rights of human beings at large and every person in particular
- Responsibility must be fully acknowledged when creating and using AI
- Humans are always responsible for the consequences of AI systems application
- AI technologies should be integrated where they will benefit people
- Significance of interests of AI technologies development outweigh the interests of competition
- It is crucial to maintain maximum transparency and reliability of information concerning the level of AI technologies development, their capabilities and risks


# Why is it needed?

To provide with recommendations to enable making ethical decisions concerning the AI creation and exploitation

To minimize unethical AI utilization that violates human rights and interests

To establish a soft regulation of the AI application

To create a self-regulated environment for interaction between the government, developers, scientific organizations and society on AI ethics



# Are ethical problems already arising? Yes, they are



#### Employment 🔀

The AI-based recruiting tool discriminated against women. Around 60% of the candidates selected by AI were males, due to patterns in the historical data on the historical recruitment of a particular developer



#### 

The European Commission published a report by an independent group of experts on the ethics of connected and automated vehicles



#### Public governance 🔀

An experimental AI system in law enforcement prompted erroneous decisions in relation to specific social groups



#### 

The AI system that determines which of the patients need additional medical care, began to made decisions, primarily based on the level of the patient's financial situation



#### Education 🔀

The AI system taught at an university for six months, but none of the students realized that they were interacting with an AI



### Who created the Code?

The AI Ethics Code was developed with the support of the state by the AI Alliance (Yandex, MTS, VK, Sber, Gazprom Neft and the Russian Direct Investment Fund) along with the scientific community and public institutions

The Code was discussed with more than **1,000 experts** working for the:

- Civic Chamber
- Federation Council
- ANO Digital Economy
- Analytical Center for the Government of the Russian Federation


The Code was launched and signed by the first participants at the Russian Forum on AI Ethics organized by the Analytical Center for the Government

# How is the Code implemented?

- Al Actors appoint officers on Al ethics who are responsible for the implementation of the Code
- Al Actors can create ethics commissions in the field of Al to consider the most relevant or controversial issues
- Al Actors can create a set of best and/or worst practices of solving emerging ethical issues

- For the implementation of the Code, AI Actors develop methods and guidelines to ensure the most effective observance of the Code
- The register of AI Actors who joined the Code is public and freely accessible on the project's site





# Why should state bodies join the Code?




- To shape policies for the development and application of ethical and trusted AI based on public consensus
